The Livemore Partnership have been instructed to act on behalf of Royal Mail Group with regards to Street Furniture. Please be informed that Royal Mail are proposing to relocate a Post Box currently sited outside the Post Office, High Street, Much Wenlock, TF13 6AA and install it on the paved area of the square at the end of the High Street, close to the junction of Barrow Street. This is due to the postman blocking the road when collecting post from the current location.

The proposed location details and style of box to be relocated can be found on the attached document.

The Land appears to be publicly owned, please can you confirm that the address does not fall within a conservation area and the council has no objections to the proposed works taking place under the Royal Mail Statutory rights Schedule 6 of the Postal Services Act 2000. If it is within a conservation area and you would like to make any alterations to the location and or style of the post box please let us know at your earliest convenience.

We aim to instruct the works within the next few weeks. Please be advised that Highways will be contacted by Royal Mail Engineering Contractors prior to undertaking any work.
