Hi, following on from our telephone conversations this week, please find the proposal for Gaskell park grass cutting.

As requested at our site meeting last week we have cut back the grow back areas at the far end of the park, we are prepared to do this on a no charge basis if it would be possible to enter into a three year contract for the grass cutting of the park as this will allow us to further invest in machinery to further improve the quality of the park. We would propose to fix the price at current levels with a % increase linked to inflation but capped at 5%. All other tasks i.e. Vertidrain would be covered under the normal quote process. This offers both parties consistency and allows our working relationships to progress and hopefully deliver a better facility for everyone.

# Gaskell Recreation Ground - On site meeting Tues 13th July 2021

### Summary of points discussed:

#### **Wild Flower Meadow**

Area: from cricket storage up to gate and seating then around squirrel corner behind and under trees to around by the newly planted oak trees to edge of slope

- Mike Humphries to research suitable wildflower mixes establishing open ground and shade tolerant species.
- Arrange a meeting with Shropshire Wildlife Trust ASAP to get further advice on seeding and
  aftercare...maybe they might have volunteers who would be involved with ongoing
  management...inclusivity of this type would be useful for future grant applications.
- Management Committee to meet briefly to agree and map out areas to be seeded. to be actioned
- Aim for seeding work to be carried out in the first two weeks of September.
- Mike to cut back the brambles near back of boundary and committee to think about weeding out brambles from Rhododendrons.
- Circulation of the playing field management plan and establish fertility priorities. emailed 16/07/21

## Tree Maintenance and planting

- Cutting back trees at Linden gate entrance to allow mower lorry access ASAP.
- Arrange site meeting with Joffrey Watson (September) to discuss tree management issues and cutting back of epicormic growth
- Agreed location for new trees under the Queens canopy initiative to be planted in diamond shape from current plantings in picnic table area on the top level to rear of the ground. Idea is to create a 'corridor' leading to windmill hill.

# Play Area

- Three benches to be removed by September and stored, temporarily, in Councillor Neal's barn. Identify
  where to reposition them in the spring.
- Arrange with Dave Thomas to cut the playground hedges (or as much that can be cut whilst avoiding equipment, soft ground, etc) as soon after 1/9/21 as possible.
- Agree to create access and replace the section of chain link fence with a suitable panel or gate.
- Committee members will be needed on the cutting day to steward members of the public
- Small repairs needed to the top leg of the children's slide, ramp to rope pull equipment and wooden roof
  of play house.

# Cricket Club Area

- Location agreed for new Steve Perks memorial bench to be installed bowling green side of current cricket pavilion.
- Discussion of possible location of new pavilion. Further discussion required

# **Bowling Club Area**

 Location discussed and agreed in principle pending supply of map with suggested location site for installation of shed

### **Grass Area**

• To agree a 3 year maintenance plan

# **Scout Hut and Grass Area**

• Clarify ownership of the ground outside the Scout hut. Responsibility for upkeep of grass and rights of access for public use – Suggested that now under the ownership of the Scouts

# 3 Year grounds maintenance plan

# Suggestions for potential 3 year plan

- Field area Pitches:
- To improve as a long term plan seeding, sand, weeding, fertilising etc (this needs pricing and time frame agreed)
- Agree yearly Verti-drain and multi sport applications
- Height of grass cut in future to be discussed for different areas of the field
- Improvement to remaining paths and installation of path to link up to windmill hill agreed in principle sometime ago but needs to finalise and agreed pending costings.
- Wild Flower Meadow exact area and type of mix to be agreed
- Plan for annual work needed to trees and low branches in general throughout whole site.
- Epicormic growth cutting.
- Plan to remedy pooling on cricket boundary.
- Add to corner of new path instead of having a right angle entry which everyone ignores by the edge of the path.
