## 8. Draft Shropshire Local Plan Review 2016 – 2038

Members noted a report on the Examination in Public. The Inspectors had made their initial comments in respect of the Stage 1 hearings. They had indicated that the Examination would proceed, but had found the development strategy set out in the Local Plan to be unsound and had requested that Shropshire Council review, update and answer the questions raised. Shropshire Council had significant work to undertake and only when this had been completed, would the Inspectors proceed to Stage 2 of the Examination, site assessments. A timescale for response was awaited from Shropshire Council but there was likely to be a considerable delay in progress.

## 9. Neighbourhood Plan – Correspondence

Members considered a letter from Much Wenlock Neighbourhood Plan Refresh Group regarding the Much Wenlock Neighbourhood Plan and urging the Council to commence a review. Councillors noted that several valid points had been made in the letter. Councillors observed that Stage 1 of the Examination in Public of the Shropshire Local Plan had now concluded and progress had been made with other local matters, such as discussions regarding the Gaskell corner.

Following consideration, **it was RESOLVED to recommend to full Council that a Steering Committee be formed to review the Neighbourhood Plan and to make recommendations to full Council.**

## 10. Mobile Home Parks

Members noted the increasing number of mobile home parks in the Much Wenlock area and the impact of these developments. Members agreed that the Neighbourhood Plan would be the best vehicle to address this issue and that the matter should be considered as part of the Neighbourhood Plan review.

## 11. Flooding Issues

- a. Report from the Strategic Flood Working Group: John Bellis, Drainage and Flood Risk Manager at Shropshire Council, had confirmed that he was working on a draft Flood Action Plan for the local Flood Action Group and Town Council to comment upon as a precursor to implementing local flood response measures at a local level, to include road closure signs and Flood Sax. There was no further action required from the Town Council at the current time. It was noted that the acronym for the Flood Action Group was FLAG.
- b. Members noted information from the Oswestry Area Committee of SALC regarding a proposed Local Flood Partnership for the county. The initial focus was likely to be on the north, west and central areas of the county with further groups perhaps being set up for the Bridgnorth and South Shropshire areas. An initial meeting would be held via Zoom on 20<sup>th</sup> March at 7.00pm.

**It was RESOLVED that Councillor Benbow would attend to represent the Town Council.**

**12. Transport Working Group**

- a. Members received a report from the Transport Working Group.

With regard to Farley Quarry, Members noted that a response to traffic issues raised by Shropshire Council had been posted by the consultant on the Shropshire Council website.

**It was RESOLVED to send a supplementary report to Shropshire Council containing the comments on transport provided to the Town Council by Paul Hanafin.**

Shropshire Councillor Daniel Thomas was asked to check the situation with regard to CIL funding for the crossing on the A458 by the primary school. It was likely that a recommendation regarding a crossing might be made as part of the WSP report on the Gaskell corner, due to its proximity.

- b. Councillors Daniel Thomas and Chris Tyler and Paul Hanafin had attended a meeting with WSP regarding the Gaskell corner earlier in the day. This was a positive meeting and progress was being made with options for traffic improvements. The next meeting would be held on 22<sup>nd</sup> March and it was expected that a proposal would be put forward by the end of March.
- c. Members noted a report on the online briefing by Atkins held on 2<sup>nd</sup> February regarding passenger transport options to support the development at the former Ironbridge Power Station site. Atkins were undertaking a rail feasibility study for the Ironbridge Power Station (currently being called Benthall Grange) to provide a rail link to the main line at Madeley junction. There had been some discussion of coaches bringing tourists to Much Wenlock, however, Councillors felt that a better public bus service from Much Wenlock would improve the viability of the rail link. It was noted that the Atkins remit covered the rail link only.

**13. Climate Change and Ecological/Nature Emergencies**

- a. Members noted correspondence from Philip Dunne MP in response to contact from Plastic Free Much Wenlock regarding the Plastics (Recycling, Sustainability and Pollution Reduction) Bill.
- b. Members noted information from South Shropshire Climate Action regarding energy advice and related webinars.
- c. There were no other relevant matters.

**14. Consultation\***

- a. Members considered a draft response, prepared by Councillor Will Benbow, on the Government's proposed approach to updating the National Planning Policy Framework as part of the Levelling Up Bill progressing through Parliament.

**It was RESOLVED to approve the draft and to submit the response by the deadline of 2<sup>nd</sup> March 2023.**
